LAS Communication to Bajaj - Repayment (Foreclosure) of the loan and Un pledging the securities

Please follow the following steps for Repayment of the loan and Un pledging the securities.

1. Please send mail to Bajaj for Foreclosure Letter to Repay the loan
2. Pay the outstanding amount and interest to Bajaj as per foreclosure letter.

Note: Kindly send mail to Un pledge the securities after 3 days of payment. If you sent mail earlier then your request will be closed by las.crm and securities will not be un pledged.

It takes 3 working days by Bajaj for the closure. The securities are Un pledged once the risk team gives clearance of outstanding.

3. Send mail for Un pledging the securities to las.crm@bajajfinserv.in

Note:- For Release/Un pledge the Securities, Mail it from your registered mail id.

Partner can also sent mail to Bajaj. Always mark client's registered mail id in CC for the mapping.

If you send mail to las.crm@bajajfinserv.in, SRN number mail will be generated and mailed by Bajaj immediately to client id. If you do not receive SRN number means there is mistake in communication. You might have sent it to wrong mail id. Please mail it again for un pledging the securities.

Note: Please attach copy of IVR for the reference.

TAT of Bajaj is two working days. It will reflect in NJ holding statement within one working day after the securities released by Bajaj.
